# Asia-Pacific Economic Cooperation (APEC)



APEC, a forum of 21 Asia-Pacific economies representing 2.9 billion people and accounting for 60% of the global GDP, promotes regional economic growth and prosperity. Australia was one of its founding members in 1989.

In October 2024, GTA's Technical Market Access Consultant, Rosemary Richards, represented GTA at the 2nd APEC Seminar on Best Practices and Applications of Digitalisation and Innovation in the Food Supply Chain, held in Beijing.

This event offered an opportunity to enhance relationships between GTA, the Australian grain industry and China's Academy of National Food and Strategic Reserves Administration, who hosted the seminar. The APEC project supports the Food Security Roadmap Towards 2030 and the Principles for Achieving Food Security Through Sustainable Agri-food Systems in the APEC Region by sharing best practices in digitalisation and innovation in food supply chains. The seminar brought together experts from across the region to discuss the integration of digital technologies in modern food supply chains.

GTA's <u>presentation</u> covered innovative technologies being adopted across the Australian grain supply chain and their potential to improve efficiency, marketing, and production. The presentation also highlighted the *Grain Industry Code of Practice*, the *GTA Technology Roadmap*, and the *Grain Industry Stewardship Framework for New Technologies*. These frameworks play a vital role in ensuring safe and reliable supply chains, offering insights and guidance for supporting the Food Security Roadmap Towards 2030.

# Independent Review of the Coastal Trading Act

**GTA Advocates for Global Access in Australian Coastal Shipping Review.** GTA recently provided a <u>submission</u> for the Department of Infrastructure, Transport, Regional Development, Communications and the Arts' review of the Coastal Trading (Revitalising Australian Shipping) Act 2012, advocating for global access in Australian coastal shipping.

Our message is clear: the grain market is complex and highly competitive, with decisions on vessel choice driven by factors like vessel suitability, market requirements, price, and service. To best serve the industry, Australian grain should access the global shipping fleet without restrictions from regulatory constraints on coastal trade, such as preferential treatment for Australian-flagged coastal traders.

Introducing such measures could lead to higher costs, reduced supply chain efficiency and flexibility, and ultimately increase expenses for Australian producers and consumers. It may also harm Australia's reputation and weaken its global advocacy for rules-based trade, free from unnecessary tariffs and politically motivated trade measures.

## Partnership with AOF

GTA recently announced, via <u>Member Update, 20 of</u> <u>2024</u> our new partnership with the Australian Oilseeds Federation (AOF) to support the delivery of AOF's functions. This partnership has been established in anticipation of AOF CEO Nick Goddard's pending retirement.

Through this partnership, GTA will work closely with AOF to continue supporting the needs of AOF members, Sustainable Grains Australia initiatives, and the broader oilseed industry. We're looking forward to collaborating with AOF in this new chapter and extend our sincere thanks to Nick Goddard for his strong leadership and dedication over the years. <u>Read</u> <u>more</u>.

## International Grain Trade Coalition

As you may be aware, GTA represents the Australian grain trade in the International Grain Trade Coalition (IGTC), with our CEO, Pat O'Shannassy, serving on its global Management Council as Secretary and Vice President of the IGTC Executive Committee. This November, Pat will attend the IGTC General Assembly in Geneva, where a global delegation of grain trade representatives from Australia, Brazil, Canada, China, Egypt, Eastern Africa, the EU, Mexico, the UK, and the USA will gather in person. The IGTC will also host a Grain Trade Seminar at the WTO.

Through our role in the IGTC, GTA continues to bring issues important to the Australian industry into global policy discussions, advocating for open, competitive markets and promoting regulatory alignment grounded in science and risk-based assessments.

## **GPPEICC Finance Sub Committee**

At a recent GPPEICC Finance Sub Committee meeting, DAFF released a budget forecast showing a projected \$3.8 million increase in DAFF's 2024/25 costs to the grain industry— a 25% rise on the last forecast provided. This substantial cost increase suggests that the current DAFF Sustainable Funding Review aims to significantly increase the revenue collected from grain exporters.

The GPPEICC serves as a forum for DAFF to consult with industries involved in grain and plant product exports, requiring DAFF to actively engage with industry members and consider their concerns.

In recent submissions, GTA has raised multiple concerns with DAFF's performance, capabilities, and funding approach. Key points include the following:

 While most other commodity groups have seen cost recovery programs running at significant deficits, the grain industry has consistently operated at a surplus.

- GTA has emphasised that the Sustainable Funding review should focus on economic efficiency rather than merely increasing revenue to cover financial shortfalls in other commodity programs.
- DAFF requires transformative change, and GTA has urged DAFF management to create mechanisms and offer transparency in its reform process. GTA suggests that DAFF senior management should engage with key exporter associations, such as GTA, to work collaboratively toward these reforms.
- A strong focus on departmental efficiency is necessary to ensure a stable platform that can support improvements across the board.

GTA remains committed to advocating for reform, especially in terms of transparency and the appropriate allocation of funding and resources specific to the grain sector.

# The 'Village' Approach to Australian Trade

At a recent industry and government forum, a key principle for maintaining Australia's reputation as a supplier of choice was highlighted. The principle emphasises the importance of industry and government providing a consistent, united message on behalf of the grain sector. This was referred to by GTA CEO Pat O'Shannassy as the 'village approach.'

The 'village approach' underscores the collective effort required to foster a supportive trade environment. It involves multiple stakeholders from both the commercial and government sectors who contribute to getting Australian grain to market. The message was clear: reputation and relationships are vital, and any disunity within government or industry can harm Australia's standing.


It's essential that both industry and government understand and respect the various layers involved in trade and trade relationships.

#### These include:

- Individual exporters
- Export supply chain service providers
- Trade associations, including GTA and AOF
- Grain producer associations and their agencies, such as Grains Australia and AEGIC
- The various government departments involved in the grain supply chain.

GTA promoted the idea that understanding individual roles is key to better collaboration, complementing one another, and contributing effectively to trade. As Pat highlighted, it only takes one from the village to disrupt the whole, and complacency is a significant risk for everyone.

## **Phosphine Residue Limits**



Under current workplace health and safety (WHS) standards, Australian grain must not exceed a phosphine threshold limit value—time weighted average (TLV-TWA) of 0.3 parts per million (ppm). This standard is based on acceptable phosphine exposure for individuals working eight-hour days over a five-day work week. However, on 1 December 2026, this official TLV-TWA will be significantly reduced to 0.05ppm, necessitating considerable changes in industry processes, including gas measurement and storage venting. Currently, the industry occasionally faces challenges meeting the 0.3ppm limit, and the stricter threshold is expected to result in additional grain rejections at receival points. Recent <u>research by the GRDC</u> indicates industry-wide issues with phosphine levels in grain delivered from farm storages, often exceeding the current 0.3ppm standard. The research found that even when grain is vented according to minimum venting guidelines, phosphine concentrations can remain above acceptable levels if grain is transferred from a silo (cleared at the top) and stored in a truck for several days.

To address these issues, the GRDC report recommends using spear tests to assess concentration levels and employing constant fan-forced ventilation for a day. Recognising the need for industry preparation, GTA will work closely with relevant Technical Committees to lead discussions and provide updated information and guidelines to members on the upcoming TLV-TWA change.
