

Standardising Grain Trading Standards, Trade Rules and Contracts enables smooth facilitation of trade within the Australian grain industry, at the same time ensuring confidence in commercial dealings by providing legal rigor and a cost-effective Dispute Resolution Service.

Informing industry

GTA provides information to enable industry participants to stay abreast of the latest trade tools through regular updates, educational programs and representation in domestic and global industry/government circles.

GTA communicates with its Members on important GTA related issues via GTA Member Updates and a monthly Grain Matters e-newsletter, as well as disseminating broader market related matters via GTA Market Notifications. All these communications are openly available and retained on the GTA website (www.graintrade.org.au).

Industry Outcomes

The goal of GTA is to create an operating environment for the commercial grain industry that is efficient, effective and transparent. These attributes provide the foundation for the Australian value chain and its members to participate in the growth of the global grains industry.

This Annual Report details the activities that GTA has pursued to ensure that these industry outcomes are achieved.

CHAIRMAN'S **REPORT**



The combined Australian Grains Industry is one of Australia's largest agricultural production and export industries and, as such, is a major contributor to the national economy.

The 2017/18 cropping season produced 37.8 million metric tonnes (mmt) of winter crops and 4.2 mmt summer crops, (42 mmt combined) with an estimated farm gate value of \$A13.8 billion of grains, oilseeds and pulses. The total 2017/18 grain, oilseed and pulse exports are estimated to be around 30 mmt valued at around \$A10.8 billion¹.

The industry is benefiting from growing domestic demand estimated for 2016/17 at 9.5 mmt of wheat, canola and pulses and 6.7mmt of coarse grains, combining at 16.3mmt² of domestic disappearance.

Unfortunately, as you read this report the current cropping season is presenting very significant production challenges particularly in NSW and Queensland and our thoughts are with the affected growers, regional communities and businesses impacted by the continuing drought.

Despite seasonal variances, the grain industry has continued to grow over the last 10 years and has evolved from a regulated export environment to what is now an open, competitive and selfregulated market that delivers value along the supply chain.

GTA's core mission is the facilitation of trade. This means, amongst other things, the movement of grain along the supply chain on a commercial basis and the ability for industry participants to manage and appropriately mitigate risk.

GTA's Trade Rules, Trading Standards, standard form Contracts and Dispute Resolution mechanisms are a key part of trade facilitation.

GTA's Dispute Resolution and Arbitration systems instills commercial confidence in our industry. Risk, in various forms, is involved in every commercial transaction and is priced into every commercial transaction. Managing risk is the core business of GTA Members. Having a reputable and efficient dispute resolution process means industry participants – including GTA members, producers and bankers – can have confidence in their contracts. If contract performance is delinquent then there is a recognised process to seek restitution.

This enshrines performance, instills discipline and creates confidence in the market. A market with no confidence in counterparties is a weak market. Increased confidence in the Australian grain market reduces risk and increases value across the entire industry. GTA is proud to play its role in delivering value to industry.

I must also acknowledge the role of our Arbitrators, who contribute their time pro-bono and are a critical part of the Dispute Resolution system. It was very gratifying to see that in a recent ACCC report on the Dairy Industry³, the GTA Dispute Resolution System was highlighted to other agricultural industries as a model for them to consider adopting.

GTA's products and services provide the grain industry with an industry driven Self-Regulatory Framework. This benefits industry by providing base operating processes and procedures, flexibility and drives efficiency across the supply chain. It is important to note this Framework has been driven and developed by industry and GTA Members through participation in Technical Committees, Industry Working Groups, consultative committees, Member submissions, Training and Development programs, amongst others.

During 2017/18, GTA has reviewed and updated its Australian Grains Industry Code of Practice⁴. We would like to thank all who took part in this review and note the important work of the Industry Working Group formed for this review. We would also like to thank the Australian Government for providing funding and endorsing the revised Code of Practice.

Australia is the only major exporting nation that has such a Code of Practice that describes the base practices and processes to ensure quality assurance across the supply chain. This is so important for our customers who need to have confidence in the Australian grain they are buying.

GTA's on-line Code Assessment Program has been developed to establish a base level awareness and understanding of the Code, the Transport Code (TCoP) and the Technical Guideline Documents (TGD)s.

The Code Assessment program and its Industry Pathway Programs create an avenue for industry to develop a degree of demonstrable Code of Practice "accreditation", and a means to demonstrate that industry understands the level of performance required in the Code and TGDs.

This is achieved by providing:

- a) Industry Participants with the learning and professional development opportunity based on the content of the Code; and
- b) Industry Employers (including GTA Members) with a structured program of professional development for their employees; a verifiable means to promote that their employees are competent and understand their obligations under the Codes and are knowledgeable of the issues outlined in the TGDs.

Over the past year GTA has established an Information Technology Advisory Committee (ITAC), to ensure that our industry keeps up with the rapid change in technology, and we are pleased this committee has been well supported by industry and government. The ITAC is tasked with ensuring GTA and the grain industry seeks to drive efficiency for the entire value chain through technology, at a non-competitive or commercial level, such as standardising industry reference data.

This committee is an addition to existing GTA Committees that cover Trading Standards, Commerce, Plant Breeding Innovation, Transport, Storage & Ports, and Trade & Market Access.

In addition, the Technical Committees commissioned sub-committees to draw further expertise and focus in several areas. These include:

In March 2018 GTA, together with Australian Oilseeds Federation and Pulse Australia, led the Australian Grains Industry Conference (AGIC) Asia series in Thailand and China.

Following the Thailand conference, cargoes of Australian Barley were sold into the market, in a process that began with the information and networks established at the AGIC Asia event.

Participation in the AGIC Asia events continues to grow. As part of AGIC Asia series, GTA led Australian industry delegations in Roundtable sessions involving local Government agencies and the trade, to support the development of mutual trading interests. These were very successful and have resulted in some encouraging projects being developed.

I would like to recognise the work and support of the Department of Agriculture and Water Resources (DAWR), Austrade, Department of Foreign Affairs and Trade (DFAT) and the respective Australian Embassies in the Industry Roundtable events.

GTA has also undertaken considerable work, on behalf of Members, on Trade and Market Access issues such as Non-Tariff Trade Measures (including Phytosanitary issues), Chemical Residues and Grain Assessment Harmonisation. GTA represents its members interests on several industry and government consultative committees and working groups, including the DAWR



Industry Consultative Committee, DAWR Industry Working Group on Non-Tariff Measures, DAWR Export Permit Working Group and the ACCC Agricultural Consultative Committee.

We have been particularly active in the development of global trade policy initiatives and frameworks through the International Grade Trade Coalition, with particular focus on trade harmonisation, objective and scientific basis for trade policies, MRL policies and innovative plant breeding techniques.

GTA, in conjunction with Grain Growers Limited (GGL) and Grains Industry Market Access Forum (GIMAF), produced a landmark report on the Impact of Non-Tariff Measures on the Australian Grain industry. This report has been used to highlight to Governments and policy makers in Australia, and globally, how NTMs can impact and restrict trade. GTA presented at several global forums including the Global Symposium on e-Phyto in January 2018, on the Impact of Non-Tariff Measures on the Australian Grains industry, at ABARES Conference in Canberra in March 2018 and the International Grains Council Conference in London in June 2018.

An industry that prides itself on selfregulation must also take responsibility for its professional culture and image. GTA has a strong track record in its Training and Professional Development program that is, and has been, the foundation of so many people in the grain industry. GTA's fully accredited Diploma in Grain Management continues to deliver value to students and the industry, in addition to contextualised training programs provided by GTA. To have an accredited, recognised training program for our Industry will place the Australian Grain industry in a strong position for continued growth and to maintain its competitive edge.

GTA also undertook to raise awareness across the grain industry on the impending changes to Chain of Responsibility legislation. This was done through the release of a Member Update and a series of Chain of Responsibility seminars held at 8 locations across the country, attended by over 150 industry participants.

The grain industry continues to develop and evolve. Recently, GTA and Australian Grain Exporters Association (AGEA) announced they were joining to create the Australian Grain Exporters Council as a sector council within GTA.

GTA was approached by AGEA and its members to seek opportunities for efficiency gains across industry and industry representation. The Sector Council concept was proposed by AGEA and its members and supported by GTA. A Sector Council provides a meeting place for an industry sector, within the governance framework and administration provided by GTA.

I thank and acknowledge the leadership demonstrated by the AGEA Board and it's President Mr. Lyndon Asser.

I would also note the work of the Australian Grains Industry Discussion Group (AGIDG). The AGIDG consists of representative groups being Australian Oilseeds Federation, Grain Producers Australia, Grain Growers Limited, Pulse Australia, Australian Grain Exporters Council and Grain Trade Australia.

Under the current Chairmanship of Grain Growers Limited, a major focus has been on the allocation of the Wheat Industry Special Account funds and developing a mechanism for on-going support and funding of several Industry Good Functions and progressing the establishment of an Industry Good Company.

GTA continues to play a key role in industry good activities. We continue to support grain quality initiatives through our membership in Wheat Quality Australia, that is responsible for Australia's Wheat Classification System, which importantly evaluates new wheat varieties in terms of end-product uses.

GTA provides secretariat support to National Working Party on Grain Protection (NWPGP) which conducts an annual open forum to address challenges and foster progress on important work on grain storage and chemical residues.

My sincere thanks to the work of the GTA staff, Technical Consultants and all the industry participants who volunteer their time to the work of Technical Committees and Industry Working Groups.

This is my last year, and annual report, as Chair of GTA. After 7 years as GTA Chairman, I advised the Board of my

intention to retire. The timing is right from both an industry and organisation perspective. It has been my absolute pleasure to serve both the grain industry and GTA members.

It is interesting and worth reflecting on where we have come as a grain industry since the industry deregulated. Despite doomsayers, and regular challenges, the industry has continued to grow and prosper.

- Crop yields and production have continued to rise despite some challenging weather impacted years. This is a real credit to our farmers, researchers and the work done by the GRDC.
- There has been a significant increase in investments in ports and storage capacity both on and off farm.
- Growers now have many more options on how they store and market their grain.

 Many of the functions once carried out by AWB on behalf of industry are now effectively covered by industry, including the work done by GTA, the National Working Party on Grain Protection and Wheat Quality Australia.

In my view, for continued success, it will be important for the industry to continue to focus on key drivers including Genetics, the Environment, Management and an Open market environment.

- Genetics Over the past few years we have seen strong advances in genetics and their potential impacts on yield, pest resistance and quality. It is hoped that with the rapid advances in plant breeding technologies – that science rather than emotion will drive their path to market and deliver the benefits that will flow from that technology.
- The only constant regarding the Environment is that it will continue to change and we must ensure the

industry adapts to the challenges and, in some cases, the opportunities these changes will bring.

- Management across the grains industry has always been at the leading edge in developing and adopting world leading practice change as evidenced by such production practices as minimum tillage and controlled traffic. There have also been significant advances in grain handling logistics and management.
- Finally, it is critical that there continues to be an open and commercially driven trade environment. We have already seen the benefits of this trading environment and we must ensure that it continues.

The biggest challenge the industry will have in the years going forward is the ability to produce enough of the quality grain that will be demanded by an evergrowing world population. I would like to thank our members for their ongoing support. GTA knows, and often states, it does not have a right to exist. It must continually earn that right from its members, by providing them with the products and services required to support their business needs.

Having been involved in this industry for some time, it is enormously satisfying to see the strong evolution that has occurred in the grains industry. The industry is well positioned and I have great confidence in its future. I expect to see it continue to grow and know that GTA will continue to play an essential role in that growth.



- In conjunction and following consultation with industry, consider quality assurance protocols across the grain value chain that assist in implementation of Trading Standards

Standards Committee Activities

The GTA Standards Committee is responsible for the annual review and development of the coarse grain and wheat Trading Standards.

During 2018, the Committee undertook its annual review of the GTA Trading Standards, calling for submissions through two rounds of consultation with industry. A number of Sub-Committee meetings considered specific issues

As a consequence of industry feedback, it was decided the 2017/18 version of the Visual Recognition Standards Guide would be used for 2018/19. Changes for the future season were identified during that process. Specific issues for change in 2018/19 Standards included a continuation of the removal of the "of which" statement in the defective category for sorghum. Further changes in other commodities are planned for 2019/20.

For barley, the tolerance for snails in all malting grades and F1 was reduced to better reflect market requirements.

The amended Wheat Quality Australia Wheat Varietal Master List was included in the Wheat Trading Standards and revised barley varietal list as provided by Barley Australia was included in the Barley Trading Standards.

All changes to Standards were included in the Standards database following its successful release prior to the 2017/18 harvest.

GTA releases the Grain Trading Standards for industry on 1 August each year following approval by the GTA Board. All current Grain Trading Standards are available on the GTA website.

COMMERCE COMMITTEE

POSITIONING STATEMENT

The purpose of GTA Contracts & Trade Rules is to facilitate trade by providing a constant and consistent methodology for conducting trade along the supply chain from producer to end consumer. The objective is greater commercial certainty, fairness and reduced risk for participants involved in grain supply chain transactions. An outcome is the promotion of broader industry confidence supporting the facilitation of trade.

GTA ANNUAL REPORT 2017/18



Following GTA Member consultation (via Member Update 10 of 17), the Commerce Committee amended the GTA Contract No.2 to include that a Seller is to provide a Buyer notice with evidence by email before 1600hrs on the last day of the delivery period, if they are aware they are in a string sale.

During 2017/2018 the Commerce Committee appointed a number of Sub-Committees to review specific issues including the Delivered Container Terminal No. 4 (DCT#4) Contract. The objective of this review was to consider a Member submission calling for improved clarity of the Contract around the Buyers Call provision, the delivery arrangements and other general areas of concern. This work is on-going, and the Committee expect to release a revised DCT#4 Contract in the latter half of 2018.

A joint Sub-Committee was also formed with the Transport, Storage and Ports Committee to consider and assist in the drafting of an umbrella style road Transport Agreement that will assist GTA Members with Chain of Responsibility compliance. The proposed Agreement places a focus on the joint review and establishment of transport related risk controls and processes.

GTA Trade Rules were also a focus of the Commerce Committee in 2017/2018. Trade Rule 18 which focusses on Circle Trades was discussed within the Committee and via Member submission. The final decision on changes to Trade Rule 18 is expected during 2018/19.

Work also continues on Trade Rule 13, Delivery and Conveyance. A Sub-Committee has the task of determining how to ensure this Trade Rule best supports the GTA Contracts and industry practice. The Sub-Committee expects to release a re-draft of this Trade Rule 13 in the latter part of 2018 and call for industry submissions.

National Heavy Vehicle Law is expected to be updated in October 2018. Prior to its introduction the Commerce Committee sought a legal review on the impact these changes may have on the existing GTA Contracts and whether updates are required to ensure compliance. This work has been completed and any required updates have been made.

Similarly, the Commerce Committee reviewed the impact of changes to the lpso Facto clauses within Australian Insolvency Laws. Change to the legislation, introduced in July 2018 allow the administrator of a company in liquidation to select which existing grain contracts are to continue and to be complied with. The Committee issued a Member Update to provide a briefing to assist Members with understanding and preparation for the change.

Following industry submission, the Commerce Committee reviewed the methodology that underpins the process of setting the South Australian Location Differentials (SA LDs). At the end of the review, the Commerce Committee resolved to maintain the current methodology with an on-going focus of review and analysis of the SA LDs.

COMMITTEE FOR PLANT BREEDING INNOVATION

POSITIONING STATEMENT

The Committee for Plant Breeding Innovation shall make recommendations to the Board and industry on the potential effect to commercial activity as a result of the:

- planned intentional release of approved GM grain events; or the
- unplanned and unintentional release (escape) of unapproved grain events
- Implications arising from plant breeding innovations

Objectives

- Ensure the appropriate commercial processes are established by GTA to enable fair and efficient trade of grain which contains approved GM crops
- Consult with and advise where required, technology proponents and other related parties in relation to "pipeline" events intended for release in Australia
- Detail processes which key stakeholders within the grain supply chain (i.e. from planting seed to end users) need to consider in advance of

any regulatory or Freedom to Operate approval for commercial release and cultivation of a GM crop is granted

- Maintain and review as required the Market Choice Framework for GM Crops
- Utilise the Market Choice Framework, where requested, to ensure a seamless integration into the Australian grain market of approved crops which will ensure market access and market choice
- Develop and maintain agreed cross sector 'unintended presence response processes that detail notifications, industry wide response options and communication strategies to be adopted should there be a detection of an unapproved GM crop
- Act as a point of contact within the grain industry to coordinate activities at an industry/government level on supply chain issues relating to GM crops of interest containing approved and unapproved GM events
- Monitor developments in relation to plant breeding innovation and develop industry responses/policies as required

The **Market Choice Framework** and **Industry Response Plan** are core activities for the Committee and the PBIC continues to consult with key industry groups regarding these documents.

TRANSPORT, STORAGE & PORTS COMMITTEE

POSITIONING STATEMENT

Ensure a competitive Australian grain industry by efficiently transacting and moving grain to domestic and overseas customers. This includes up-country receival and storage, rail and road transport, and efficient and equitable bulk and container port facilities.

Objectives

- Foster communication between the Board, Management and the Transport Storage & Ports (TS&P) Committee on industry matters that relate to logistical and supply chain issues
- Advise the Board of any recommendations made by the Committee in relation to changing legislation such as Heavy Vehicle National Law and Chain of Responsibility
- Advise the Board and report to industry on all other matters of relevance addressed by the TS&P Committee
- Report and make recommendations to the industry on potential changes to process and systems that may reduce impediments and provide a more secure and safe supply chain

Transport, Storage & Ports Committee Activities

Safety within the grain supply chain continues to play a major role and focus for the Committee. An appointed Sub-Committee is progressing the development of grain supply chain safety principles that will support company safety policies and procedures.

Impending changes to the Heavy Vehicle National Law (HVNL) and subsequent impact on Chain of Responsibility (CoR) compliance has been a particular focus for the Committee – developing awareness and industry tools to manage its introduction.

The Committee has reviewed and updated the Grain Transport Code of Practice and, through active involvement and submissions, has played a role in shaping the outcome of the Transport Master Code of Practice that is under development. This input focussed on ensuring the Transport Master Code encompassed some of the key aspects of grain road transport.

Based on feedback from GTA CoR Compliance seminars, the Committee, in conjunction with the Commerce Committee, appointed a joint Sub-Committee to consider and draft an umbrella style Road Transport Agreement that will assist GTA Members with CoR compliance.

Process and documentation issues combined with food grade container supply shortages, inherent to the grain container supply chain, has been another focus for the Committee. This is a complex area with multiple participants. Issues and potential remedies have been examined and discussed with the Department of Agriculture and Water Resources, Shipping Lines, Container Terminals, Exporters and Container Packers. This work is ongoing with an objective to improve the sustainability and performance of this supply chain.

Biosecurity within the supply chain remains a focus of the Committee. Due to cross-contamination of grain and treated fertiliser concerns, an initiative, generated and driven through joint discussion with the fertiliser industry, has resulted in the development of a one-page Fact Sheet promoting awareness and the requirement to wash out any transport and handling equipment.

The Committee endorsed a submission into the Government's National Freight and Supply Chain Strategy. This submission proposed fourteen recommendations supporting strategies for improvement to the country's infrastructure, planning and supply chain co-ordination.

Objectives

- Monitor developments in local and international grain environments and policies and develop appropriate responses for the Australian grain industry where required
- Where required assist GTA to liaise, provide submissions and collaborate with industry supply chain organisations and/or government in developing appropriate responses to developments in local and international grain environments and policies

- Provide guidance to GTA on deliberations at grain trade forums both in Australia and international that directly affect the Australian commercial grain trade operating environment
- Provide guidance to GTA on implementation and communication of outcomes arising from forums noted in Point 3

Trade & Market Access Committee (TMAC) Activities

The TMAC provides input across a broad range of trade and market access issues and supports a very active program of work undertaken by GTA in this area.

The TMAC commenced the year with a face to face meeting in Melbourne with guest speakers including Katy Lee from IGTC and Richard Simonaitis from AEGIC.

Key activities for the Committee across the year included:

 China – ongoing monitoring of the Industry Management Plan, support and advice regarding issues around the wheat and barley protocol, development of proposals for new approaches regarding sampling and testing, support for the AGIC China event and Roundtable meetings

- Participation in free trade agreement discussions and submissions in conjunction with other grain industry sectors
- Participation in outwards and inwards grain missions

INFORMATION TECHNOLOGY ADVISORY COMMITTEE

POSITIONING STATEMENT

Ensure the grain industry is sufficiently adaptable to capture the benefits of changes and advances in information technology, enhancing the facilitation of trade, through consultation and collaboration across the supply chain.

Objectives

- Advise the GTA Board of recommendations made by the Committee detailing opportunities to collaboratively investigate system, process and research initiatives that may resolve common grain industry process and transactional issues
- Foster communication amongst GTA Members and seek opportunities to share information, ideas and learnings across companies in the development of industry reference material, including common transactional processes
- Report and make recommendations • to industry on potential changes to process and systems that may reduce impediments and support improved facilitation of Trade
- Identification of risks, gaps and opportunities for the grain industry from a data and information technology perspective
- Provide a consultative and advisory function to GTA Board, Technical Committees and, on behalf of industry, to stakeholders including Government Departments, Agencies and other relevant stakeholders to improve data exchange across industry and Governments (local and global) to facilitate trade efficiencies

Information Technology Advisory **Committee Activities**

During 2017/2018 the GTA Board approved the establishment of a new Technical Committee - Information Technology Advisory Committee (ITAC). The Committee's focus is on the data and transactional areas of the grain industry.

Following GTA Member requests the decision to introduce ITAC was based on the grain industry's high reliance on data and transaction processes, the many interactions between value chain participants, combined with the rapid pace of innovation in information technology.

This flow of data is important to the efficient facilitation of trade across the value chain. The nature and flow of data means there is potential scope for a broad and neutral organisation (such as GTA) to play a role in providing a collaborative and consultative platform for a cross section of industry.

GTA Members assisted in shaping and defining ITAC's role and objectives through participation at an industry Forum held prior to the formation of the new Technical Committee. This Forum held in Melbourne on 9 May 2018 allowed the wider member base an opportunity to discuss and provide input into the scope and objectives of the Committee.

The Information Technology Advisory Committee will become increasingly important to Members and the wider supply chain given the fast pace of change as new technology is introduced. Value will be generated for GTA Members through the provision of a forum to review and share information and address how industry uptakes new opportunities in technology.

Similarly, sharing of common problems and the joint design of initiatives to resolve these problems must generate greater efficiency than companies operating in isolation. Given the cost of Information Technology is a large burden on all business any opportunities to ensure effective design and expenditure in this area will be beneficial.

Disputes requiring a legal remedy are minimised due to the contractual integrity of GTA contracts, trade and arbitration rules which take precedent from Australian Contract Law and state and internationally based Commercial Arbitration Acts.

- GTA works to resolve disputes by peer review, through its Dispute Resolution Process. The process is designed to save time and expense while providing an efficient, fair and equitable means to settle disputes related to commercial transactions.
- All domestic arbitrations are subject to the provisions of the Commercial Arbitration Act NSW (2010) whilst arbitrations that involve international parties and the GTA FOB contract are conducted under the International Arbitration Act 1974 (Cth).
- Parties utilising the Dispute Resolution Service (DRS) must cover all the inherent costs associated with conducting arbitration without cross subsidisation from other GTA revenue streams.
- Aligned to this principle must be the commercial reality that the GTA DRS must be competitive to other forms of dispute resolution, particularly court proceedings.
- GTA Arbitrators are industry practitioners acting impartially in a voluntary capacity.

GTA TRAINING & DEVELOPMENT PROGRAM

POSITIONING STATEMENT

GTA will deliver training programs that develop and enhance the capacity of the industry's human resources, ensuring that trade facilitation processes are well understood at all links in the grain value chain.

Grain Trade Australia has become the main developer and deliverer of market-specific accredited training and professional development programs for the grain industry.

GTA will be recognised as an organisation that encourages and recognises its strength and support to the upskilling of the grain sector workforce and leadership attributes in industry personnel.

GTA Diploma of Grain Management

The past year has seen the first graduates for the Diploma of Grain Management. The first two graduates were awarded their Diplomas in August 2017 at AGIC Melbourne. South Australia and Western Australia were the first states to have candidates awarded the Diploma.

This is an exciting development for GTA and the grain industry in Australia. To receive the Diploma, 10 units must be completed – 3 core and 7 electives.

THE DIPLOMA IN GRAIN MANAGEMENT IS THE ONLY POST-PRODUCTION, GRAIN-SPECIFIC ACCREDITED COURSE IN AUSTRALIA.

GTA has been delivering the Diploma of Grain Management, an accredited qualification, for three years. The Diploma of Grain Management is a fee for service qualification and is modelled on self-paced learning. The Australian Skills Quality Authority (ASQA) regulates gualifications and training providers, to ensure nationally approved quality standards are met. The ongoing review and development of resources by industry experts for the implementation and delivery of the Diploma has been recognised by industry. This places the Diploma in a strong position in its ability to deliver accurate and current information with direct context and relevance to the grains industry.

The Diploma was included on the Industry Skills list in 2018, which will further the recognition of this qualification.

To achieve the Diploma, 10 units must be completed – 3 core and 7 electives. A list of the units delivered in the Diploma of Grain Management is available on the GTA website

 The Diploma is now recognised, established and supported within the industry sector, with 190 commencements and students having graduated in the Diploma with a number having completed skill sets. Interest in the Diploma has increased significantly, with enquiries from all sectors of the industry. The opportunity of completing individual units from the Diploma to form skill sets, relevant to the varying work place skills and knowledge requirements, has proven to be popular. An accredited Statement of Attainment is awarded on completion of a skill set.

 Industry personnel completing the Training & Development workshops have the option to complete the formal assessment for the relevant unit in the Diploma on the online Student Learning Platform. This platform allows the student to access contact with the trainer/ assessor and streamlines the process of assessment for the student.

THE GTA TRAINING & DEVELOPMENT PROGRAM ENSURES THAT TRADE FACILITATION PROCESSES ARE WELL UNDERSTOOD AT ALL LINKS IN THE GRAIN VALUE CHAIN.

- Recognition of Prior Learning (RPL) is offered for those who have previously attended GTA courses or believe they have met the requirements of the Diploma through relevant industry experience. The RPL process has proven to be a positive pathway for many students and can be used for all or part of a unit.
- GTA is able to deliver in-house training which is streamlined for organisations that have a number of staff requiring upskilling in specific areas. GTA has delivered several workshops to corporate clients, in specific skills and knowledge areas, and contextualise the workshop content to meet individual organisations requirements, related to a skills and knowledge gap. This has proven to be a positive pathway in meeting individual organisations staff training goals.
- GTA Training & Development delivered two stand alone workshops during the year. In May the two day Export

Documentation course was delivered in Melbourne. The course covered the necessary documents from the export trade to delivery, and the ten presenters were all industry experts in their fields. Participants from all states attended. The one day Advisory and Compliance workshop was delivered in July and once again the topics were varied and of specific interest to the participants. These were delivered by six presenters highly respected in their fields.

- To support the GTA core objective • of a well informed industry, Chain of Responsibility (COR) Seminars were delivered to address the changes in Legislation occurring from July 1st 2018. The seminars delivered information to the grain sector on the basis of "Can your business comply". The presenters, Tim Ross, GTA Projects Manager and Geoff Farnsworth, Partner - Holding Redlich and Director of the Australian Logistics Council, delivered information regarding the history of COR, the impact, risk, responsibilities for all parties linked to in the grain transport suplpy chain. Seminars were delivered in Dubbo, Melbourne, Bendigo, Sydney, Toowoomba, Adelaide and Perth with 156 attendees.
- Further development and implementation of resources for the Diploma and other training needs will continue.
- GTA has developed training and assessment programs to assist its members and industry participants to upskill their staff and meet the needs of the Australian Grain Industry Code of Practice. This Code Assessment Program is an on-line training tool comprising assessment modules in specific grain value chain pathways.
- GTA Training and Development programs are available to all interested parties as well as GTA Members.

Registered Training Organisations (RTOs)

GTA has partnered with the following RTOs who are responsible for ensuring GTA applies the appropriate level of academic rigor in the conduct of the Diploma units. The RTOs may also offer some elective units for the Diploma. It is beneficial for GTA members and the wider grain industry to have providers that cover the grain belt across the country.

The organisations are:

Great Southern Institute of Technology – Albany WA

Established in 1974, the Institute is the largest training provider in a region that covers an area of 40,500 square kilometres. Primary campus is located in Albany with five other sites throughout the southern areas of the state.

Wodonga TAFE – Albury/ Wodonga VIC & NSW

Founded in 1986, Wodonga TAFE is a highly regarded training institution that captures both regional VIC and NSW. Training is also delivered in every mainland state and territory in Australia. Wodonga was judged Australian Large Training Provider of the Year in 2008.



TRADE & MARKET ACCESS

Trade and Market Access continues to be a core and growing task of GTA. In line with this, GTA has increased its activities and resources in relevant initiatives over time. A critical component of the trade and market access activity is developing industry priorities and advocating these with Government. As such, GTA works closely with the Australian Government and international colleagues to pursue outcomes that benefit the grains industry.

Current trade and market access activities are outlined below.

1 DEPT. OF AGRICULTURE & WATER RESOURCES – GRAIN AND PLANT PRODUCTS EXPORT INDUSTRY CONSULTATIVE COMMITTEE (GPPEICC)

GTA is an active member of the GPPEICC and several sub-committees such as Finance, Sampling, Request for Permit and Mobile Bulk Loading.

The Grain and Plant Products Export Industry Consultative Committee (GPPEICC) is the principal forum for the Department of Agriculture & Water Resources (DAWR) to consult with grain, fodder, nuts, seed and timber industries on export inspection and certification, export market access and other relevant issues.

GPPEICC aims to provide effective consultation, communication and partnership between DAWR and industry stakeholders involved in export of Prescribed Goods by ensuring stakeholders' views are given due consideration.

Major issues addressed by the GPPEICC:

- Fees and charges grain export program
- Industry Management Plan (IMP) for the Chinese Wheat/Barley Protocol
- Export Permit Request Processes (Request for Permit)

- Authorised Officer (A0) Bulk Vessel inspection at anchor
- Introduction of global e-Phytos ((International Plant Protection Convention)
- Development of an International Standard on Phytosanitary Measures on the International Movement of Grain
- Review of Export Legislation
- Representative sampling of export cargoes
- Development of export management
 IT systems
- Authorised Officer (AO) program
- Mobile Bulk Loading systems

2 DEPT. OF AGRICULTURE & WATER RESOURCES – AGRICULTURE POLICY GROUP

GTA maintains a close working relationship with the DAWR Agriculture Policy Division. Over the last twelve months, GTA has had more proactive involvement with the policy division in relation to:

- the Australian Grains Industry Discussion Group strategic plan for industry good activities and use of WISA Funds
- Australian Government representation at international meetings such as Global Initiative on Low Level Presence, COP-MOP relating to biosafety protocol, International Standard on Phytosanitary Measures (ISPM)
- Review of Port Code
- Market Access for Australian grains
- Free trade agreements and regional Government initiatives through forums such as APEC, ASEAN, etc

3 MARKET ACCESS ACTIVITIES


GTA significantly increased its activity in market access activities during the year.

Importantly for the industry, the focus on non-tariff measures was moved front and centre with several key activities, including:

 GTA led a project on Identifying and Prioritising Non-Tariff Measures (NTMs) – The GTA CEO chaired an industry steering committee that oversaw this project, funded by DAWR and GRDC, and resulting in the development of a landmark report for the industry.

The results of this first comprehensive survey of non-tariff measures (NTM) which affect the Australian grains industry provided the opportunity to communicate to government, and international and domestic stakeholders, the impact of NTMs for the purpose of improving market access for Australian grains and delivering improved farm-gate returns for Australian grain growers. The project brought together representatives from across industry, led by Grain Trade Australia, GrainGrowers and GIMAF.

Successive Australian governments have been highly effective in liberalising international trade with key grain trading partners. Free Trade Agreements and World Trade Organisation reforms have delivered a reduction in tariff rates across a range of export markets, resulting in the expansion of export market opportunities. However, while tariffs and quotas are still important in some markets, in general they are now less restrictive and harmful for the grains sector than the emerging and growing NTMs that affect trade.



The report identified some 54 NTMs across 15 markets, including many of Australia's most important markets.

The Steering Committee is continuing its work to develop strategies to address the identified NTMs.

- ii. Development of a market access database which will capture and manage market access issues for the industry. This was developed in conjunction with GIMAF with funding from the Wheat Industry Support Account (WISA).
- Representation on and active participation in DAWR's NTM Working Group which is a cross commodity group that assists the Government prioritise NTMs. This has, for the first time, provided the grains industry with a voice on this Committee.

GTA has worked closely with GIMAF to review and shape tools such as the China Industry Management Plan to build confidence with both the Australian and Chinese Government authorities that Australian grain meets all import requirements, while ensuring that the grains industry can continue to operate efficiently and cost effectively.

GTA has worked with GIMAF to provide input into Australian Government submissions to overseas markets on various technical matters relating to trade.

GTA proactively initiated and facilitated roundtable industry/Government discussions in Thailand and China as part of the AGIC program. Supporting these roundtables, GTA worked with Grain Growers Limited to develop a submission to the Indonesia-Australia Comprehensive Economic Partnership Agreement negotiations in relation to improved access for feed grains.





4 GLOBAL POLICY DEVELOPMENT – GTA AND THE INTERNATIONAL GRAIN TRADE COALITION (IGTC)

The development of trade agreements, on both bilateral and multi-lateral arrangements, captures the attention of the media, however, and generally behind the scenes, there is substantial trade policy developments taking place generally via United Nations (UN) related agencies. These policies/protocols have the potential to disrupt or stop the trade of grain and hence it is critical that the grain trade are active participants in their development.

To ensure that Australian grain exports are not impacted, Grain Trade Australia works with a number of likeminded organisations, world-wide, on trade related matters that are pre-competitive. This is achieved through our membership of the International Grain Trade Coalition (IGTC). A defining feature of these negotiations at an international level is that progress is slow and can take years. Nonetheless, it is critical that Australia participates in their development, as once they are ratified, they will then become the standard for Australian grain exports. This issue is well recognised by the various Australian Government agencies – in particular, the Australian Government Departments of Agriculture & Water Resources, Health, Environment and Foreign Affairs & Trade.

Key activities included:

- Cartagena Protocol on Biosafety to the Convention on Biological Diversity
- Development of Global Low Level Presence (LLP) policies relating to the export/import of GM grains
- Plant breeding innovation regulation and industry information sharing policies
- Chemical Issues such as maximum residue limits (MRLs)

- Development of e-Phyto capability
- International Standard on Phytosanitary Measures

Development of an International Standard on Phytosanitary Measures on the International Movement of Grain

Development of this proposed standard is being conducted under the International Plant Protection Convention and when finalised will affect shipments of grain from Parties to the Convention, i.e. all the major exporting and importing pathways.

GTA action: *GTA will liaise with the Australian Seed Federation and CropLife Australia to ensure that Plant Breeding Innovations are introduced in a manner that does not disrupt trade. GTA is an active participant in the IGTC Working Group. GTA has provided submissions to both the OGTR and Gene Technology Scheme reviews.*

Global Low Level Presence Policy Initiative

Low Level Presence (LLP) is the presence of trace amounts of a GM event approved in the country of export but not in the country of import. Australia is a member of the Global Initiative on Low Level Presence (GLI) which is a group of like-minded Governments that have come together to discuss issues around LLP policies. GTA, via IGTC, continues to have input into development of LLP policy frameworks.

GTA action: *GTA will continue to advocate that Australia needs to have a strong representative presence at GLI meetings and will continue to actively participate in IGTC activities on LLP.*

Chemical Residues (MRLs)

GTA continued liaison with the IGTC and National Working Party on Grain Protection (NWPGP on the impacts of MRLs on food safety and global trade of grains. Through IGTC a survey of industry on the impacts of missing MRLs in importing countries for various chemicals and commodities was developed. Ongoing advocacy with IGTC, DAWR (Trade and Market Access, National Residue Survey) and industry continues.

GTA Action: *GTA continues to liaise* with all parties in Australia and with *IGTC on the impacts of MRLs on the effective export of grains from Australia in order to pursue development of MRLs that facilitate trade and do not compromise food safety.*

Cartagena Protocol on Biosafety

The Cartagena Biosafety Protocol (CBP) is a founding issue for the IGTC and relates to the international movement of products that may contain Living Modified Organisms (LMOs) derived from modern biotechnology. In June 2018, the 171 Parties to the Protocol cover more than 85% of the world's grain trade movements. IGTC has advocated strongly at all Meeting of the Parties (MOP's) to ensure that the Protocol would not inhibit trade.

Every two years, national and regional governments that are 'Parties' to the CBP meet to amend or update core texts, as well as agree on guidance to implement specific provisions. These negotiations take place as part of the wider UN 'Convention on Biodiversity' (CBD) and its other provisions such as the Nagoya Protocol on Access and Benefit-sharing. As such, the meetings are often referred to as the 'Conference of the Parties' (COP) and the 'Meeting of the Parties (MOP).

GTA action: *GTA remains engaged in discussion on the Protocol, through participation on the IGTC working group. GTA continues to advocate that Australia needs to have a representative presence at COP-MOP meetings.*

NATIONAL WORKING PARTY ON GRAIN PROTECTION

The National Working Party on Grain Protection (NWPGP) is the body responsible for providing management and leadership to industry in the areas of grain storage, chemical use, market requirements and chemical regulations.

The annual conference of the NWPGP is a forum providing participants with the latest research and developments in the area of post-harvest storage and hygiene, chemical usage and outturn tolerances, international and domestic market requirements and regulations. It also discusses industry's performance in meeting market access requirements for chemical maximum residue limits over the preceding year.

GTA acts as the secretariat for the NWPGP and will continue to undertake this role during 2018/19. GTA further supports the NWPGP by planning and administering all aspects of their annual conference.

2018 Annual Conference

The NWPGP Annual Conference (known as the **Australian Grain Storage and Protection Conference**) took place in Melbourne on 19-20th June 2018 with over 130 delegates in attendance.

Delegates came from the entire grain supply chain and included growers, storage and transport operators, end users, traders, researchers, chemical registrants and related service providers, and government agencies. It also attracted several international delegates. The conference program was diverse and included speakers covering:

- Updates on industry efforts to meet changing Market MRL requirements
- Industry performance in meeting market MRLs
- Latest Insect infestation trends
- Discussion on Pesticide residue violations and systems to minimise their occurrence
- The latest storage practices
- Research into alternative measures to implement the Insect Resistance Management strategy
- The effectiveness of previous research activities into storage and insect control management practices

A number of industry working groups were formed including:

- The phosphine label has continued to be reviewed and the working group continues to develop a strategy for adoption of the recommended changes to the label.
- The Glyphosate on Barley working group continues to review data developed from trials reviewing the impact of use on barley.
- Development of recommendations for implementation of various storage type designs on-farm and in the BHC system.
- 4. A number of working groups are reviewing specific chemical/ commodity use issues and the impacts on marketing of grain. Similarly, data available for industry use from residue testing programs is being considered to assist industry endeavours to meet market requirements for chemical residues.

The full list of outcomes from the Conference is available on the GTA website but in summary they included:

- Continued support for the current NWPGP mechanism involving liaison between the Chair of the NWPGP and the National Residue Survey to facilitate the establishment and or maintenance of overseas MRLs as requested by industry
- Compliance with market MRLs remains at a very high level as per recent seasons
- A number of applications are being considered to overseas countries for adoption of Import tolerances for various chemicals and commodities of importance to the industry
- The Australian Grains Industry Post Harvest Chemical Usage Recommendations and Outturn Tolerances document which details the chemicals that are permitted for use post-harvest and applicable Maximum Residue Limits (MRLs) for various grain commodities out turned to Australian domestic or export markets has been updated and also placed on the GTA website for industry use



AUSTRALIAN GRAINS INDUSTRY CONFERENCES

The Australian Grains Industry Conference (AGIC) continues to be a key activity for GTA each year with the annual program now expanded to include domestic and international conferences with the development the AGIC Asia program. While the annual AGIC Australia conference in Melbourne continues to attract delegates from right across the trade and supply chain, the AGIC Asia events have a core focus on end users in key Asian markets and delivers a more technically based program. AGIC Asia now includes Government Roundtable meetings as part of the overall program. The Roundtables seek to engage with Government agencies and discuss relevant issues including quality assurance processes in the Australian grain supply chain.



AGIC Australia – Melbourne, 2nd & 3rd August 2017

The 2017 Australian Grains Industry Conference was highly successful with over 800 delegates participating in conference activities at various stages over the two days; strong sponsor support; high level of media coverage; new look exhibition and several high level international and local speakers.

The 2017 Conference program was built around the theme of "*Global Trends* – *is quality Australia's Trump card?*" and featured a high-level "CEOs in Conversation" session involving Emma Alberici in conversation with Tim Hart, CEO Ridley, Brenden Bourke, CEO Melbourne Ports and Graham Turley, Managing Director Institutional Banking, ANZ.

A strong list of international and local speakers included sessions on global markets, trade policy trends, domestic demand trends, and the impacts of technology and investment on the grains industry.

The conference was opened by The Hon. Joel Fitzgibbon, Shadow Minister for Agriculture.

AGIC continues to be the key Australian grains industry event of the year and, in addition to the Conference itself, a number of other industry organisations schedule meetings around the event. The Conference is a highly sought-after event for industry participants to network and hear from high quality experts presenting on key areas of interest and impact for their businesses. It also continues to grow as a key venue for exhibitors to access a targeted customer base in the grains supply chain.

AGIC is co-hosted by Australian Oilseeds Federation, Grain Trade Australia and Pulse Australia. GTA is the Conference Organiser.

AGIC Asia – Thailand and China – March 2018

GTA expanded its AGIC Asia program in 2018 with events in Thailand (Bangkok – 20th March) and China (Shanghai – 22nd March). This year's events built on the success of last year's conferences in Vietnam, Indonesia and China. Attendance numbers for the two events were strong with over 280 people in attendance over the two venues.

Asia is an extremely important and significant market for the Australian Grains Industry. Providing information and a clear and consistent message about the Australian industry, its quality and reliability is very important for all sectors of the Industry and particularly for Australian grain growers. The theme this year was around Australia's value proposition comprising grain quality, nutritional features, surety, reliability, reputation and confidence.

The events were well attended by both flour and feed millers and reinforced the strong position that Australian grain holds in these markets. AGIC returning to China was strongly supported with solid attendance at the Shanghai event. The China event featured a presentation from local Professor Li Dogsen on beneficial methods of using Australian flour for noodle making and closed with a demonstration of noodle and bakery products made exclusively from Australian wheat.

This year the program, again, featured roundtable discussions in both countries - Bangkok in Thailand and Beijing in China. This was the second year the Roundtable activities were held by GTA and were targeted at leveraging the AGIC Asia events to improve Government and industry relationships in key markets. The Roundtables have increased opportunities for trade facilitation, market access and promotion resulting in improved development of trade policy and communication between respective Asian and Australian industries, at both a commercial and technical level.



The AGIC Asia conference and Roundtable events are very valuable to supporting the maintenance and growth of these important markets for the Australian grain Industry.



FINANCIAL PERFORMANCE & POSITION [EXTRACT]

Financial policies

- 1. Adequate cash reserves will be maintained to conduct the operation of the business and complete the objectives detailed in this and subsequent Strategic Directions. GTA will maintain cash reserves equivalent to 75% of the budgeted expenses in any one year.
- 2. Membership fees will fund "trade facilitation" products and services, i.e. the GTA management team and Technical Committees; and
- 3. All industry support products will be offered to members at a fee that will encourage participation but also reflects a reasonable return on funds invested by the broader membership.

Financial position

GTA recorded a surplus of \$303,953 with equity of \$1,174,916 and cash reserves of \$1,289,981 which falls within the cash reserves policy set by the GTA Board.

As a not for profit organisation, GTA cannot distribute profits or build excessive cash reserves.

The financial position as at 30 June 2018, allows the GTA Board to invest with confidence in services and products for the benefit of all members.

Major contributing factors to the financial accounts:

- Funding provided by Dept. Agriculture & Water Resources (DAWR), through the Package Assisting Small Exporters, resulted in a review of the Australian Grain Industry Code of Practice which underpins the self-regulatory framework provided for all GTA members and the wider grain industry. Whilst there was no financial gain from this activity, ultimately, all of industry benefits from the provision of the service.
- AGIC ASIA 2018 activities resulted in a deficit of \$4,000 against budget. Although the financial result could be considered disappointing, the tangible benefits from this activity have been quantified by GTA members as an increase in export activity. This affirmative action will drive the continued delivery of this program.
- 3. The company successfully applied for acceptance to the Export Market Development Grant list. This entitled the company to apply for the reimbursement of funds expended in the past in pursuit of Export Market Development activities amounting to \$125,705 which has been recognised as income during the year.
- Following a comprehensive review of members' categories for the 2016-17 financial year, several members were re-aligned to a more appropriate category of membership – resulting in an increase in membership fee revenue of approximately \$55,000.
- 5. Expenses to operate GTA were again contained to essential services, resulting in a significant reduction against budget. Actual expenditure \$1,016,524 against a budget of \$1,081,543. This containment facilitated additional project services expenditure, directly benefiting members.
