

# National Working Party on Grain Protection Notification Process of non-GM Herbicide Tolerant Varieties due for Release

#### A. Introduction to Process

This suggested process for notification of non-GM herbicide tolerant varieties under development and their associated chemical(s) has been designed specifically to determine if any residues (through either the active ingredient or their breakdown products) have a deleterious effect on market access for the commodity to which that variety belongs.

Reference should also be made to the document "Notification of Release of non-GM Herbicide Tolerant Varieties Sep19".

To assist in the evaluation process, it is recommended that the chemical(s) associated with the variety to which it is tolerant are registered by the APVMA for use on that commodity and have a domestic MRL.

There is no set timeline for the notification of information outlined in this document prior to release nor assessment of notifications as this depends on a range of factors and each notification will be evaluated on a case-by-case basis. To assist in the consultation process it is advisable to provide information as early as possible in the development process. Where required, commercial in confidence material should be clearly noted in order for the Chair NWPGP to protect that information.
