# 1. Background

The GTA Commerce Committee called for nominations and submissions for the GTA Location Differentials for the 2023/24 season on the 2<sup>nd</sup> of February 2023 via Member Update 1 of 23. A total of two (2) submissions were received.

The Commerce Committee has since met and outcomes from discussion of that submission can be found below. The Committee is now calling for further nominations or submissions on the listed issues. The current GTA Location Differentials can be found on the GTA Website.

Ungarie Hanlon is currently a road only status in the Location Differential table. Information to support the application was provided including supporting correspondence from rail companies.	Committee reviewed the Submission and agreed to accept the proposed change in status for the Hanlon Enterprises Ungarie site to a ROAD OR RAIL site.
2.	GTA	Removal of Moulamein Grain Co Op site	Moulamein Grain Services Pty Ltd were placed under voluntary administration in August 2022 and are no longer hold a GTA membership.	GTA Board agreed to the cancellation of the membership of Moulamein Grain Services Pty Ltd.

## 5. Special Notes

- Change in a Site Operating Company should be advised to GTA and new LDs requested.
- Otherwise, Sites currently listed with a GTA LD do not need to be re-nominated to be listed in the coming 2023/24 season. GTA will assume these sites remain as listed.
- Only GTA Members are entitled to nominate their sites for LDs
- All sites large or small, rail or road, are eligible for a GTA LD.
- Sites must also be formally nominated to be withdrawn from the GTA LD schedule.
