- Otherwise, Sites currently listed with a GTA LD do not need to be re-nominated to be listed in the coming 2021/22 season. GTA will assume these sites remain as listed.
- Only GTA Members are entitled to nominate their sites for LDs
- All sites large or small, rail or road, are eligible for a GTA LD.
- Sites must also formally nominate to be withdrawn from the GTA LD schedule
