TOPIC: Wheat & Barley Exports to China – 1. GACC Provision of a list of Australian Export Registered Establishments; and 2. Required Authorised Officer job functions for exports of wheat & barley to China DISTRIBUTION: GTA Members – primary contact list. Please circulate to all appropriate internal parties.

1. Status Update

- The DAFF Grain and Seed Export Program has announced China's General Administration of Customs of the People's Republic of China (GACC) has released an updated list of approved Australian wheat and barley establishments and exporters.
- DAFF has announced that Authorised Officers (AO) that inspect wheat and barley for export to China are required to have additional job functions.

2. Summary of Changes & Key Points

GACC approved Australian wheat & barley establishments and exporters.

- On the 19th of June 2023 GACC has released an updated list of approved Australian export establishments and exporters. This is the first update since June 2020.

 - The first sheet in the spreadsheet are registered establishments that can pack wheat and barley for export to China.
 - The second sheet in the spreadsheet are approved exporter of wheat and barley to China.
 - The third sheet in the spreadsheet are registered establishments that can pack dried beans (peas and mung beans) for export to China.
 - The fourth sheet in the spreadsheet are registered establishments that can pack oats and sorghum for export to China.
 - The fifth sheet in the spreadsheet are registered establishments that can pack oilseed for export to China.

All AO's inspecting wheat and barley for export to China will need to ensure they have the correct DAFF job
functions as outlined in the Table of authorised officer job functions
