Review process

The review process to develop the 2011/12 grain standards was as follows. Further details are in the Explanatory Memorandum referred to above.

- 3.1. Via Member Update No 05 of 11 GTA Standards Review the Standards Committee called for industry submissions. This Update also included a detailed Explanatory Memorandum which detailed:
 - Proposed changes for adoption in 2011/12
 - Potential changes for 2011/12 where further industry advice is required
 - Issues that were previously considered for change in 2011/12 but not accepted for progression by the Committee
 - Proposed changes for adoption in 2011/12
 - Issues for further Industry Consideration in future.
- 3.2. There was 10 submission received from members and the broader industry.
- 3.3. The Committee met on 8 April 2011 to consider the submissions and released on 5 May 2011 a detailed explanation of proposed changes via Member Update No 12 of 11 GTA Standards 2011/2012 Season.
- 3.4. Three submissions were received from industry from this second round of consultations. These submissions were considered at a meeting on 17 June 2011 and after consideration the Standards Committee has made final amendments to the standards for 2011/2012.
- 3.5. The 2011/2012 Grain Standards were presented to industry at the Grains Industry Common Interest Forum held in Melbourne on 25 July 2011.
