The Guide is developed by the GTA Standards Committee through comprehensive consultation with the major bulk handling companies, including CBH, Viterra, Cargill and GrainCorp.

The Guide covers a wide variety of commodity defect definitions and photographic references for wheat, barley, oats, sorghum, maize, chick peas, canola, lupins and lentils.

4 GTA Trading Standards Review Process

GTA Member Update No.2 of 13 and No.10 of 13 sought feedback from industry on potential changes to grain standards for the coming seasons. Feedback was received from a range of industry sectors on the proposed changes and a range of other issues.

The GTA Standards Committee (the Committee) met in 2013 on several occasions and reviewed feedback from industry. The Committee recommended changes to the GTA Board and the Board has adopted recommendations as appropriate (refer to the GTA Explanatory Memorandum 2013).

5 Process for Implementation

As the 2013/14 Standards have been adopted by the GTA Board, the final Standards have been published on the GTA website at <u>www.graintrade.org.au</u> and are now available for industry use.
