TOPIC: 2019/20 Location Differentials for SA

1 Issue

The 2019/2020 South Australian [Location Differentials \(LDs\)](#) have now been finalised post the Consultation for 2019/20 SA Location Differentials as per [Member Update 31 of 19](#).

2 Amendments to LD's in South Australia

The GTA Location Differentials in South Australia are derived from the Viterra Export Select Rates provided to GTA.

The Commerce Committee reviewed and discussed Submissions received by GTA Members and finalised the SA LDs for GTA Board approval.

For most SA sites where the site is not owned by Viterra, the Committee adopt the same methodology that GTA employs for QLD, NSW and VIC. This methodology uses road distance to port of the particular site, based on Google Maps and a per km rate for the nearest Viterra site adjusted for distance. Where a site exists in a town with a Viterra site, all sites in that town will be allocated the Viterra LD, in accordance with the SOP.

Variations to this methodology can be approved by the Committee when considered necessary. Following a Submission, the Committee recommended a revised LD for AWB Mallala resulting in a differing LD to Viterra Mallala. This change was to reflect consistency with neighbouring sites.

SA sites with a port destination in an adjacent state use the same methodology employed in the destination state e.g. Victoria.
