### **Economic Forces...**

- GTA understands:
  - Shipping market driving consolidation
  - Leverage is currently with Shipowners
  - COVID-19 = Chaos = increased freight cost
  - Grain feels impacts a/c volume/value
- Markets should be allowed to operate freely and drive supply/demand balance
- GTA Technical Committees established the GTA position
  - Shipping Industry has reacted to market forces
  - However, Aust structural reform process has fallen behind
    - Review & understand Policy Settings
    - Generate reform through existing processes = Harper Review 2015





### **Policy Settings**

#### 2015 Harper Review – Temporarily paused

- Measured response to an extensive review
- Removal of the supports for ongoing special treatment of the liner shipping industry
- Consideration of extending the review to infrastructure charges
- Relevant today?

#### Collaborative Discussions Importers & Exporters

- 23 Industry Associations not all exposed directly to the supply chain
- Seeking clarity discovery process of market forces / structural issues
- Group focus is to advocate a Govt review
